

Schedule of Programme Re-approval – 2018/19 to 2022/23

The schedule of programme re-approval is determined in the first instance from the date of last PQR when formal re-approval of programmes within a department occurred. However, it may be the case that substantive revisions have been made to those programmes in the meantime, or accreditation activity has occurred which has effected a mid-term re-approval. In those cases the information below may be void and re-approval can be scheduled to a later date. **Where such interventions have occurred for programmes which impact on the scheduled re-approval date, programme teams are encouraged to contact their Quality Assurance and Enhancement Manager or AQSC to discuss further.**
